CIRCULAR

Aizawl, the 3rd May, 2023.

No.B.16021/37/2016-IND: The Industrial Area Management Committee, Industrial Growth Centre (IGC) Luangmual noted that certain individuals and entities are occupying and encroaching upon Government land at IGC, Luangmual without valid land allotment orders. Such unauthorized occupation and encroachment of Government land is not only illegal but also poses a serious threat to the development and progress of our State.

Therefore, the Industrial Area Management Committee, IGC Luangmual in its meeting held on 06.02.2023 has resolved as a matter of policy vide No.D.11028/3/2023-DTE-IND(Infra) dated 03.04.2023 that in order to curb this menace, it is hereby notified that no application for water and power connection within Government land may be entertained without the production of a valid land allotment order or consent certificate from the Commerce and Industries Department.

All concerned Government Departments are requested to take strict action against the unauthorized occupation and encroachment of Government land and to ensure compliance with the guidelines issued by the Commerce and Industries Department.

All stakeholders are requested to cooperate in the efforts of the Government to protect the public property from unauthorized occupation and encroachment.
