## EDITORIAL



I have spent around two years in Mizoram and the belief which I am carrying now is that it can be a land of opportunities. Although it is projected as a remote state but I find it as strategically located between Myanmar & Bangladesh and the need is to formalize our trading with these countries. It has ample availability of bamboo but rather than using it to enhance the standard of living of our people here through value addition, it is being fed and lost in the paper mills of the neighboring regions. Exploitation is rampant under the present system of Mahaldars but despite that is has been continuing for years. Present world is talking about globalization but why it is not buzz word of Mizoram. Many other examples can be quoted and which if addressed properly can transform this state as land of opportunities.

Now let me concentrate on the industrialization scenario in the state. The Govt. of India has made a wonderful policy – NEIIPP which provides tremendous incentives in the north east. I have thought a lot and I do not deny that this policy could have been better but in present form also it couldn't yield the desired results. Why is it so? The only basic reason is that the state is lagging in entrepreneurship. Good seeds will not yield anything if the land is not ready for cultivation. This is the basic reason that the people are using this policy to generate fake claims but is this business of fake claims sustainable. Certainly not and that is why basic tool of entrepreneurship has to be generated for taking up sustainable business ventures in which policies can act as facilitator.

So now the question comes of how to develop entrepreneurship? Exposure tours, skill development access to knowledge etc. are all available means which can help you in making a good entrepreneur, but can these in themselves generate entrepreneurship? I certainly believe these are good facilitators but to be an entrepreneur one has to change the way one thinks. One should be ready to take well informed risks, able to generate required resources and should be patient enough to tide over the gestation periods. In context of Mizoram for this thing to happen we have to focus strongly on our youth and should try to imbibe new and open perspective in them. We have to make them ready to face the stiff competition outside and make them ready to experiment with new concepts like globalization.

I would like to stop my discussion here and would continue on some other topic in next issues to come.

Bul tan nana capital an neih loh avangin sorkar hian ruahmanna eng emaw siam sela an duh thu an au chhuahpui thin bawk. Chu chu Mizoram mi challang tam tak pawhin an ngaihdan a ni a, thalaite harsatna sutkian dan tur sawi thin politician-te pawhin loan lak dawna dahkham neih ngai kher chu thil buaithlak a nih thu an sawi fo.

Hetih lai hian a tuma tum tan chuan kawng a awm ve tho mai; pakhat chu *free*

*collateral security* niin a dang chu *credit guarantee scheme* hi a ni. Free collateral security chu industry tenau atana cheng nuai nga chin hnuai lam loan latute dahkham dah phut kher lo tura Reserved Bank of India-in bank hrang hrang hnena hriattirna a siam hi a ni a. Credit Guarantee Scheme (CGS) chu loan latuten an loan an rulh theih loh palha rulhsak an nihna tur a ni. Heng ruahmanna pahnih bakah hian rampawn lama thil thawnchhuah tur ten sum lama harsatna an tawh lohna turin Export Credit Guarantee Corporation of India pawh India sorkar chuan a siam bawk.

Ruahmanna pahnihte hian Mizoramah chuan hmelhriat an hlawh lo hle. Industry lama state a la hnufual vang pawh a ni mai thei. Mithiam leh nawlpui ngaihah pawh industry lama hmalakna turin Mizoramah hian kawng a awm lo tih a ni deuh tawp. Tih tur dang hre lo emaw industry ringawt atchilh emaw tan lo chuan hriat ngaihna a awm lo emaw tih hial tur a ni. Dik tak chuan ruahmanna pahnihte hi Haukhum Hauzel-in Mizoram

chief secretary a nih laia a sawi hma kha chuan vantlang hriatah sawi a ni ngai lo. Chumi hnuah CGS chu sawi a awm leh zauh thin a, vantlang hriatah sawi chhuahna tak tak chu May 2, 2009-a Mizoram Entrepreneurship Network (MEN) leh Small Industries Development Bank of India (SIDBI) tangkawpin he scheme chungchanga workshop an neih leh chumi hma lawka MEN general secretary Joseph L Ralte-in tualchhung chanchinbu thenkhata article a ziakte hi an ni. Mizoram Chamber of Industries & Commerce pawhin February 3-19, 2010 chhungin CGS chhawr tangkai a nih theihna turin entrepreneurship training an huaihawt ve a, chhunzawm zel an tum bawk.

Lehkathiam leh thiam lo pawhin an lungkham ber chu sorkar emaw mi hausa hnuaih emaw inhlawnha zawn hi a ni ber a, entrepreneurship lam mipuiin an ngaihven theih nana hmalakna a awm lo va. India sorkar ruahmanna pahnih tihlawhtlingtu tur bank-ho advertisement hmuh tur awm chhun

chu personal loan, housing loan leh car loan a ni. Chung chu service loan a ni. An sumdawnna mutual fund etc hmuh tur a awm thin bawk. Bank hi puhchhiat ngawt tur an nih leh nih loh erawh hriat thiam a harsa hle. Bank-hoin loan an pek chhuah tam ber chu service loan a ni a, chu chu thlatina hlawh late an hlawh atanga loan an rulhna tur lo laksak tura loan pek hi a ni. Thlatina an hlawh lak tur atanga lo lak mai turah pawh hian bank tawngkam takin 'recovery' a la tha lutuk chuang lo va, PMRY-ahte thleng hian manager thenkhat chuan dahkham an phut phah hial nia sawi a ni. Chutiangah chuan bank-ho hian dahkham neih ngai lo loan hi puang puang ngam tur an ni em tih pawh zawhna awm thei a ni hial. Chutiang bawkin a thehdarha, a mamawhtute hnena hlui leh kaihruaitu tur zingah pawh hian hun eng emaw ti chhung chu hma han la tak tak tur an awm lo a ni. Mizoram thalai beidawng nia insawi tam tak chuan tanpuitu (facilitator) an lo nei lo va; zirna chuan inhlawhna zawng tur a chher chhuak a ni mai si a, lekhathiam zingah pawh hian sumdawnna lam thil lo zir fuh bik leh tlema inchhiar zau deuh lote chuan kal ngaihna an lo hre lo ni awm tak a ni. A hriate pawhin mimal chuan han haichhuaha, chhawr tangkai ngaihna an lo nei emaw, chutiang ti turin chakna (capacity) an lo nei lo a ni mai thei.

Ruahmanna chu eng tianga tha pawh lo awm se loan chu pawisa puk a ni a, a puk tirtuin a pek ngam tlat loh chuan tih ngaihna vak a awm lo. CGS leh free collateral security loan te rulh leh ngai lo loan an nih loh avangin bank leh financial institution-te chuan thuneihna sang tak an la nei tho. "Cheng nuai

nga thleng pek theih chu a ni a, a tak takah chuan nuai nga chu kan pe ngam chiah lo a ni," tiin Aizawla bank manager pakhat chuan a sawi nghe nghe. An loan pek tur hi an ring ngam tur a ni a, an sumdawnna tur chu hlawhtlin beisei awm a ni tur a ni. Free collateral security loan pawh hi vantlangin hre vak lo mahse bank chuan an pe chhuak lo chu a ni chuang lo. CGS pawh sumdawnna lama mit lo keuh tawh thenkhat chuan an lo tangkaipui tawh bawk.

CGS-ah hian loan latuin a rulh theih loh pawha lo rulhsaktu tur Credit Guarantee Fund Trust for Micro & Small Enterprises (CGTMSE) a awm a; hei hi August 2007-a India sorkar leh SIDBI tangkawpin an din a ni. India sorkar hian an pawisa thawhkhawm hmun nga-a then a hmun li thawhin SIDBI hian a hmun khat lo thawh tura tih a ni. A tirah chuan cheng vaibelchhe 125 an thawhkhawm phawt a, chumi hnuah vaibelchhe 1736.68 thawh-khawm lehin vaibelchhe 2500 thawh-khawm an tum mek a ni.

Sorkarin a ruahman dan chuan loan pek ngam leh ngam loh teh nana dahkham tur neih leh neih loh hman thin aiah loan hmanga hna thawh tur that leh that loh chu teh nana hman zawkna tur a ni a, loan la pha lo leh thei lo an awm bik lohna tur a ni bawk. Mahse, he scheme hian loan latuin a rulh theih loha rulhsak turah hian huam chin a nei a, India hmarchhaka chengte chu an loan lak hi cheng nuai nga aia tam lo a nih chuan 85% hi an rulh theih loha rulh sak tur hian a huam a, cheng nuai 50 chinah 80% huam bawk. cheng nuai 65 chauh a huam thung. Sorkar ngaihah chuan small leh medium enterprise hi ram economy hnuk pakhat a ni a, agriculture tih lohah chuan eizawn nana hmang an tam berna a ni. Tichuan, hetiang lama hmalakna hian a tha zawngin nghawng thiak a nei thei dawn niin SK Alam, CGTMSE deputy general manager, Kolkata chuan a sawi nghe nghe.

CGS loan hi Member Lending Institution (MLI) an tihte hian an pe thei a, bank ni kher lo financial institution - NEDFI (North East Development Financial Corporation) leh National Small Industries Corporation (NSIC) te pawhin an pe thei a ni. India ram pumah hian MLI 80 an awm a, mahse, a thawk tha tak tak chu 52 an ni. Mizoramah chuan SIDBI leh SBI ten he scheme hnuiah hian loan an pe tawh niin an insawi. Loan latute hian fee chawi tur an nei a, annual service fee leh guarantee fee te an ni. Heng fee-te hi MLI (loan petu) ten an loan pek atanga an lo tihfel tur a ni a, CGTMSE-ah an lo pek tur a ni. Loan latu tan CGTMSE hi dawr buai a ngai lo niin SK Alam chuan a sawi. Annual service hi India hmarchhaka chengte tan chuan cheng nuai nga chinah 0.5% pek tur a ni a, a aia tamah chuan 0.75% pek tur a ni. Guarantee fee hi

India hmarchhaka chengte tan chuan 0.75% pek tur a ni bawk. Fee hi loan lak atanga chhut tur niin fee pek ngai zat hi kum khata thla awmzat 12-a sem a, chumi chhuak chu thla la awm zata puntir tur a ni.

Dahkham neih a ngaih loh avang hian loan hi bat ral theihah ngaih tur a ni lo. Dahkham (collateral security) hi third party guarantor tite pawhin sawi a ni a, chumi awmzia chu loan latuin ba a rulh theih loha bank-in a pawisa ba hu sum an lakna tur a ni. A loan latu a fihlim ta tihna a ni lo. CGS hnuiah miin loan lo la se a rulh theih loh chuan MLI (bank) hian beisei tur awm tawh lo (non-performing asset)-ah a puang ang a, chutah CGMSE chuan MLI hnena a pawisa pek tur first instalment a pe phawt ang a, MLI 'recovery proceeding' tia an sawi mai hi, a ti phawt ang a, dan hmangin loan latu thil chhuhsak tur awm ang angte an chhuhsak dawn a nih chu. Chumi hnuah second instalment a pe leh ang. Second instalment a pek hnuah MLI-in a la hloh tur chu CGTMSE nen hian an intum sem ang a, CGTMSE chuan an intum sem tur hmun lia then hmun thum a tum ang a, MLI-in hmun khat a tum dawn a ni.

Chuvangin loan hi thil beisei awm loah pawh awlsam taka lak mai theih turah ngaih tur a ni lo. MLI hian thil beisei awm loah pawh loan pek maina turin he scheme hi a hmang tur a ni lo a, project hi bank-in an enfiah dan pangngaiin uluk takina enfiah ngei ngei tur a ni.

Pathian Lehkhabuah Pathianin ni ruk chhungin Vana ni leh Thla leh Arsi zawng zawng te, khawmual leh a chhunga thil awm zawrg zawng te leh tuifinriat leh a chhunga thil awm zawng zawng a siam dante min hrilh a, chung a thilsiam ropui tak tak te chu tu te ta tur leh tu te chhawr tur leh hman tura siam nge tih ngun taka chhuiin anmahni anpui mihring siam a tum avangin an mamawh tur leh an chakkhai tur zawng zawng leh an chenna tur Eden huan pawh anmahni a siam hmain a lo siamsak lawk vek a, an khawsakna tura hmanrua leh mamawh tur te a siam zawk vek hnu, a ni rukna chawhnu (PM) ah khawvel a siamchhan mihring a siam a ni tih min hrilh a ni.

Ni ruk chhung leka a siam khawvelah hian a mihring siamte mamawh tur zawng zawng leh ramsa leh nunna nei chi zawng zawngte mamawh tur pawh a siam kim vek a, chu thu chu a ni a siam kim loh tia tuman sawi tur kan hriat loh hi a makna chu a ni. Pathian chu engkimtithei leh finnaa khat a nih avangin ni ruk chhung leka a thil siam zozaite hi an tlo hlawm em em a, *planet* hote leh vana arsi chhiarsen lohte pawh khian an kal kawng (Orbit) kum sang tam an zawk tawh hnu pawhin an hloh ngai lova, an zawk sual ngai lo bawk.

Pathian themthiamzia leh makzia hi mihring finna mai chuan, “A then pawh kan hre thei lo, he ui kam atang hian,” tih ang chauh kha a ni a. Hlaphuahtute hian Pathian

ropuina hi an hril thiam ber a ni.

Rev. Carl Gustav Boberg chuan, “Aw Lal Pathian, I kut chhuak thilsiam tin reng, dawn changin mak tim ka lo khat thin.” tiin a phuah a. zel a, nakin deuh zelah chuan a huhoa tiho dante hrechhuak zelin workshop dinna changte hre chhuak zelin a tawpah chuan INDUSTRY DEPARTMENT hial dinin a lo awm ta a, tunah chuan pi leh pute hun laia thilte chu sawi loh kan nu leh pate ho khawsakna hmanraw tin reng pawh kha hnawl tawhin kan in leh kan dinhmun te, kan ei leh in te, kan silhfen leh bungbel te pawh a hmingte chu hming pangngai pu reng hlawm mahse a *quality* erawhchu a dang daih tawh hlawm a ni. ## NLUP PROJECT

### A Package of Transformation Development Programme

**1.** Mizoram is basically an agrarian economy being dependent on subsistence oriented agriculture interlinked with other land based activities such as livestock and forestry etc. In the past in view of availability of vast Jhum land and Small population, the farming community could maintain, though low, a satisfying level of equilibrium. But increased population growth, changes in land use pattern resulting in loss of fertility and natural

forest has profoundly impacted the economy rendering Jhum practices unsustainable.

**2.** Mizoram like other states in North East are endowed with untapped natural resources. Fertile soil, abundant rainfall characterized by rich cultural background and thus ideal for launching viable developmental activities. The added advantage unlike other states of North East is the peaceful atmosphere, homogeneous society and its forward looking people with highest literacy next to Kerela are critical to any developmental initiative. In fact like other states in North East, Mizoram suffers paradoxically from poverty in the midst of plenty. Non-Sustainability of Jhum practices, shrinkage of jhum cycle over many past years has given immediately to the problems of food security and increased poverty. In the absence of viable alternative livelihood option, about 3.00 lakhs work force in Mizoram are engaged in low productivity eking out a subsistence or distress living in rural areas. Long term impact on economy will be still more disastrous owing to destruction of rain forest of 1.5 lakhs acres of land every year, heavy soil erosion

and resultant ecological imbalance.

**3.** Admittedly any developmental intervention would require addressing the whole gamut of issues through a holistic approach for integrated farming system development, commercial orientation of agriculture and generation of natural resources. Thus the objective of empowering the rural poor of Mizoram needs to address wide range of problems and constraints that hampers rural development. These problems express themselves

- (a) *at the household level in terms of food security,*
- (b) *at the production system level in terms of low productivity,*
- (c) *at the community level in terms of poor infrastructure and service delivery and*
- (d) *at the supply chain level inadequate access to input and output markets including financial services. These problems are interrelated, leading to vicious circles and resulting in poverty traps; often exacerbated by natural resource degradation as is now conspicuously happening in Mizoram*

---

*with declining Jhum cycles being a case in point. In order to break out of these poverty traps, there is a need for a holistic approach that allows for dealing with these interrelated problems in a simultaneous fashion.*

**4.** The present Government of Mizoram on assumption of office in December 2008 has embarked on massive programme of socio-economic development. Amongst others the New Land Use Policy (NLUP), a flagship programme, at the vanguard of the transformation development package of activities targets growth rate from current level of 6% over 7 years period with core objectives as below :

- a) To stop jhum practices and wean away jhumia families to adopt sustainable on-farm and off-farm economic activities introducing commercial farming and value addition etc.
- b) To create food security
- c) To restore ecological balance through afforestation, soil & water conservation and other eco-friendly programmes.

One of the unique features of NLUP is that will be integrated Land Use Planning at the Village level as follows :

- a) 60% of land will be earmarked for rain forest.
- b) Additional 10% of land will be earmarked for Community Reserve Forest for protection of catchment area of rivers and water supply sources.
- c) 10% of land for fuel/timber Reserve Forest to meet community consumption

requirement.

- d) 15% of land for cultivation under NLUP and the remaining 5% will be earmarked for habitation, road, industrial area etc.

Entire project under NLUP will be formulated at the village level. Various Centrally Sponsored Programmes will be converged for optimum utilization of funds. It will produce one of the most far reaching land reform in a tribal area where customary land holding system prevails till today. Mizoram will be the first State in India to venture in this type of land reforms aiming at survey of the whole State, introduction of new land ownership, regulation and management system.

The village level plans will be merged to form district plan which will produce the best model of integrated development and district plan by introduction of integrated planning and project implementation.

It is worth mentioning that NLUP concept experimented during 1985 – 1999 inspite of shortcomings had produced some success stories. In fact an “independent Church Organisation” after their evaluation commented favourably about the potential of NLUP in the context of Mizoram. Reputed Chennai based consultancy firm which studied the past NLUP experiment also appreciated the concept and suggested for improvement in plan formulation implementation and evaluation in the NLUP Project efforts have been made to incorporate necessary remedial steps to avoid constraints

to which the first NLUP Project was subjected to. It is also known that informed public opinion is of the view that there is no better alternative plan strategy to transform Mizoram Economy.

Project will cover 750 villages in 40 clusters of prospective crop zones identified through remote sensing targeting 1,20,00 families over a 5 year period on-farm and off-farm activities like Agriculture, Horticulture, AH & Vety, Soil & Water Conservation, Sericulture, Fisheries, Industries including Handloom/Handicraft and forestry supported by infrastructure components like minor irrigation, water harvesting, agri link road, rural godown, processing units are the project. Project size is Rs.2873.13 crores of which beneficiary contribution amounting to Rs.346.00 crores. Project has the inbuilt provision for appropriate linkages including access to output markets.

Project Implementation is entrusted to 3-tier Management System ranging from state

level policy making body upto village level planning and implementation, involving the concerned line departments monitoring, accountability and social audit are the hallmarks of the project to ensure transparency and prevention of leakage of funds.

Targets Project impact/result are as below :

- a) All Jhumia families will progressively switch over to permanent and sustainable livelihood activities with higher income, having ownership of land, access to infrastructure like irrigation, water harvesting and remunerative prices for produce.
- b) Judicious mix of Agriculture-horticulture activities, AH & Vety, Fisheries, Handloom, Sericulture etc. is expected to diversify the economy & increase income by 7-10 times (compared of jhuming) ensuring inclusive growth.
- c) The over all growth of economy (SDP) to 16% from 8<sup>th</sup> year against average growth rate of 6% during 1<sup>st</sup> 10 years.
- d) After 10 year per capita income is expected to increase from Rs.32,634 in 2008 – 09 to Rs.51,846.00
