He Scheme hi April 1, 2017 atanga March 31, 2022 thleng hman tura ruahman a ni a, A Scheme-in a kente chu hengte an ni:

2. Central Interest Incentive (CII).
3. Goods & Service Tax (GTS) Reimbursement.
4. Income Tax (IT) Reimbursement.
5. Transport Incentive (TI).

Hei vang hian ram changkangah chuan an kutchhuak thilsiam an roh ፻tha leh a. An chawi lar thar leh mek a, mahni kutchhuak zahpui a hnekin an chhuang zawk mah a. Keini Mizo pawh hian kan kutchhuak kan chawisana kan vawrh lar chhoh zel hi kan tih makmawh niin a lang.

Suk leh Sum

A hmasa berah chuan suk leh sum hi han sawi hmasa ta phawt ila. Tunhma, rei pawh a la ni lo, kum sawm nga emaw lekah kha chuan Mizo in tinah suk leh sum hi hmuh tur a awm a. Suk leh sum tel lo chuan Mizo chhungkua a awm thei lo a tih theih ang. Mahse, tunah chuan suk leh sum a vang ta hle mai a. Thinglang khuaah meuh pawh suk leh sum nei lo chhungkua an tam tawh em em a. Khawpui naupang tan phei chuan hmuh tur leh hmelhriat tur a vang ta hle mai a. Hriat pawh an hre meuh tawh lo a ni.

Chutih laiin khawl hmanga thil den dip emaw densawm leh kan sum leh suk hmanga densawm hi a in ang lo em em a. Chhangban ngat phei chu a in tui

hleih hle a. Khawl densawm leh suk leh suma densawm chu Mizo pa ka dik tak chuan a hre hrang ፻thin. Buh, suk leh suma den leh khawl hmanga her pawh a ei a innawm hleih khawp a. Chuvangin, kan hmanlai suk leh sum hmanga thil den chu tunlai khawl hmanga den hian a tluk ngai lo han ti leh phawt mai ila.

Thembu

Mizo thembu pawh hi lak bo ang maiin a vang ta duak bawk a. A aiah puantah khawl kan hmang a, mizo hmeichhe tam zawkin mahnia tah tum tawh lovin midang tahsa lei kan intih hmuh a. A ፻tha, a lawmawm khawp mai. Mahse, mizo puanbu hmanga tah kha heng khawl hmanga tah hian an tluk thei hauh lo tih chu kan hmeichhiate hian an

hre chiang khawp mai. Puan inang reng pawh khawl chhuak man letin mizo puanbu aṭanga tah chu an lei ngam a. Hei hian a danglam zia a tarlang awm e. Chuti chung chung chuan kan thembu hi hmuh tur a tlem ta hle mai a. Khawpui leh thingtlangah pawh khawiah mah uarna hmun leh chawilarna hmun a awm ta lo. Kan zing aṭang hian mizo thembu hi a bo lek lek niin a lang. Amaherawhchu, mizo thembu ngei aṭanga puan zeh chu a mawi a, a hlu em em zawk tih chu phat rual a ni bawk si lo.

Chutiang a nih avang chuan state pawn lam aṭangin mizo thembu chhuak ni awm tak, a laia zungthui ve ngat tlawm tak taka hmuh tur a lo awm phah ta a. Kan ḫenawm state aṭangin a lem a lo lut ta nghek nghek mai a. Puantah khawlin puan chanve an tah a, thembu aṭanga tah angin a zung an han ḫhui a. Mizo nu ngei hian mizo kut chhuak dik tak, thembu aṭanga tah ngei nia hriain an lei duh em em mai a. Hei hi thil chhinchhiah tlak leh mahni kutchhuak thilsiam hlutna tarlannaah a ngaihtheih awm e.

Tuithawl, Tuium, Haite, Fenthlir...

Kan tuithawl leh tuium pawh hmuh tur a vang tawh khawp mai. Tuithawl leh tuium bakah haite leh fenthlirte pawh an bo zo ta. Heng tui kan chawina leh kan khawihna hmanraw pawimawh tak tak hi plastic leh thil dang

changkang zawk nia kan hriatin a luahlan zo ta bawk a. Dik tak chuan plastic hmanga thilsiam reng reng hi mihring tan an hrisel tawk lo fo va. Khuanu kut chhuak *tuithawl, tuium, fenthlir* leh *haite* kan hman ḫhin zawng zawng kha an hrisel em em a. Tourism Industry ti changtlung tur leh mi hip thei zawnga kalpui tur phei chuan keimahni kutchhuak thilsiam ngei hi hmang thei ila. Mauthei hmang hian in turte in tulh thei ila. Tuithawl leh tuium hmang hian tui chhawp ila, fenthlir leh haite hmangin han suah tir vel ila. Plastic no mawi tak tak hman nuam zawk nia kan hriat ai hian mikhual a hip zawk daih ang. Chakai rem si lova man reng theihna hi kan ram tan a ḫha tawk a. Man tam tum luat avanga damdawi emaw hmanga hrai ang phei chu kan hlawkpui

lohzia kan hre awm e. Chakai bakah nungcha dang zawng zawng pawh an thi a. A dam chhun pawh, zeng leh damlo chawrche takin an nung ṭawk ṭawk a. Han man leh mah ila an sa ei tlak a ni meuh lo. Chutiang chu a nih avangin, thilsiam keimahni kut chhuak ngei mai hi kan tan a ṭha tawkin an hlu em em a ni.

chuan nakin lawkah ṭhangtharte chuan an la theihnghilhin a hlutna a bo der thei a. Thawkkhat lai khan hnam siamna atan hian plastic hmang an awm a. A hmuh a nuam a, a tlawm zawk bawk a, a fakawm viau va. Khatianga tlawm taka lei tur an awm khan mi tam takin thil phurh nan an hmang a. Mutia bakah mimir zingah Hnam hmang kan tam phah hlein a lang. Khang ang pawh khan Mizo kutchhuak thilsiam a chawi sangin a ti hlu thar lehin a lang.

Mizo kutchhuak thilsiam tam tak hi tun lai hunah chuan a ṭul tawh lo ve kan ti pawh a ni maithei a. Ngun taka ngaihtuah erawh chuan hluihlawn leh kalsan ai chuan a tunlai thei ang bera siam dang lam emaw chei danglam emaw ni se. Mizo kutchhuak dik tak thilsiam hlutna phochhuak thei tura kan mizo thil ngaihsan thara chhawm nun that leh hi tih makmawh a ni a.

South Indian Food pawh a ngai reng a, Punjabi Lungi leh Roti pawh a danglam kan hre lo. Chutiang chu a nih mek laiin Mizo kutchhuak thilsiam tam tak hi an hlutna a bo mek niin a lang a. Keini Mizo chauh hi kan kut chhuak thilsiam vawng nung tur leh a hlutna tarlangtu tur kan ni a. Hnamdang tuma'n min tarchhuahpui ngai dawn lo va. Keimahni ngei hian kan Mizo kutchhuak thilsiam hi kan hlut thiam a, a bo pilril

mai loh nan'a hmalatu tur leh hnamdang
hmaa phochhuaktu tur kan nih kan hriat
a ngai a. Kan kutchhuakte hi nalhin tha
hle mahse, kan hlut thiam loh chuan
hriateng pawh a hlawh lo vang a, kar lo

Hei hi ni 19.5.2017-a duan a ni. Kum 2016-2020 Five Year Plan chhunga hmatakna atana duan a ni.

1) Mega Food Park: Hei hian thlai thar, ransa, sangha leh a dangte a hlawn/huhova awmte hmanraw changkang leh tunlai thei anga thuam a, an thilsiamna tur leh siamsa mumal zawk mamawhtute nena indawrna tha siam lam a hawi a. Chuta thawktute zirtirna tha zawk pekte a kawk.
