And whereas, in exercise of the powers conferred by Section 11 of the MSME Development Act, 2006, the Mizoram Procurement Preference Policy for Micro & Small Enterprises, 2025 has now been introduced by the government of Mizoram vide. No. B.16017/05/2020-C&I, dated 25.02.2025 with more comprehensive provisions than the aforementioned Rules, thereby promoting the development of Micro and Small Enterprises in the state, the Governor is pleased to order that the Mizoram Preferential Stores Purchase Rules, 1994 shall cease to operate with effect from the date of issue of notification of the Mizoram Procurement Preference Policy for Micro & Small Enterprises, 2025.

Subject: **The Mizoram Procurement Preference Policy for Micro and Small Enterprises, 2025.**

Sir,

I would like to state that the Mizoram Procurement Preference Policy for Micro and Small Enterprises, 2025 comes into force with effect from 4.3.2025, i.e. the date of its notification in the Mizoram Gazette. The Policy document has also been circulated to all the departments vide No. B.16017/05/2020-C&I dated 25.2.2025.

In this connection, I would like to draw your kind attention that as per Para 18, every procurement entity is required to prepare a procurement plan along with annual budgetary allocations for a financial year and the plan shall be updated as per approved annual budget allocation for the entity. Further, State Government departments or agencies are required to prepare annual procurement plan for purchase and upload the same on their official website so that MSEs may get advance information about requirement of procurement agencies.

You are requested to take necessary action in this regard so that the aims of the Policy at promoting and developing micro and small enterprises at the state by giving preference in procurement of these products and services may be achieved.
