

Food Labelling kan tih hian a awmzia ber chu ei tur funna pawn lama a siamtu leh a thil siam sawi chianna a ni ber a. Labelling a tarlan tur chi hrang hrang Dan-in a sawi a awm a, chung chu thil siamtu reng rengin an zawm tur a ni a. Chu lama hma latu chu **Food Safety and Standard Authority of India (FSSAI)** Ministry of Health & Family Welfare a ni. He Dan hi thil leitute himna leh an thil lei tur hriat chian nana thil t̄angkai leh pawimawh tak a ni a, mipuite'n kan chhian chian fo a pawimawh hle a ni. Food label-a tarlan ngei ngei ngaite han sawi ta ila, ei tur siamtu (manufacturer) te pawh kan pung zel a, label-ah hengte hi chuantir tur a ni.

Thilsiam hming (Name of Food):

Chumi hnuah, kum 2006 October khan Govt. of India chuan The National Mission on Bamboo Technology and Trade Development Report, 2003 behchhanin bamboo industry tihhmasawn nan National Bamboo Mission a rawn siam chhuak ta a. Amaherawhchu, mau chin (bamboo cultivation) lamah hmasawna engemaw chen chu lo thlen ve bawk mah se, mau hmanga thilsiam (bamboo processing) lamah hmasawna nasa tak a thlen lem lo. Tunah hian Restructured National Bamboo Mission hi Govt. of India hmalaknain tih leh a ni a, a hma aiin hmasawna thlen tawh tura beisei a ni.

Bamboo processing lama hmalakna tur kan ngaihtuah dawn chuan a hmasa berah hlawhtling tura kan zirchian tur chu thil tul pawimawh tak pali Four Factors of Production (Land, Labor, Capital leh Entrepreneurship) hi a ni.

Land - hei hi ram mai bakah a chhunga leilung hausakna, entirnan; thing, mau, oil, etc.

Labor - hei ni hnathawktu tur mihring a tul ang thawk thei tura hriatna leh thiamna nei a ni.

Capital - hei hian pawisa hnathawh nan a hman tur bakah khawl leh hmanraw dangte a huam a ni.

Entrepreneurship – harsatna awm thei tur thlir chungah mahni a hlawhtlinna thleng thei tura sumdawna kalpui mi nihna.
