**LZ Ox** = *L.Z Oxygen, Industrial Estate, Zangtui*

**LM:** A hmasain inkawmna hun tha tak min pek avangin lawmthu kan hrilh a che.

**LZ Ox:** Kei pawh ka lawm e.

**LM:** In industry L.Z Oxygen tih hi eng nge a awmzia, a lampum min hrilh thei em? In veng leh chhungkaw chanchin te min hrilh thei em?

**LZ Ox:** L.Z Oxygen tiha L.Z. hi ka hming Lallawmzuali tih lamtawi a ni a, ka hming chawia phuah a ni. Kan pa chu Dr. C. Silvera (L) a ni a, tunah hian Tuikhuatlangah kan khawsa mek a ni.

**I.M :** Engtik aṭangin nge in tih ṭan a, Sawrkarah te in inziak lut tawh em?

**LZ Ox:** Kum 2014 kumtir lam aṭang khan a hmun hmate kan buatsaihin hma kan la ṭan a, May 2015 khan kan inpeihfelin oxygen siamna khawl hi comissioned a ni. Commercial production hi June 2015 aṭang khan kan lo ṭan tawh a ni.

Sawrkar hnuiah - Industries Department-ah hian registration neiin kan inziak lut fel tawh a. Tin, department hrang hrang - Taxation Department-ah te kan inziak lut bawk a. Tin, heng bakah Health Department hnuia Food & Drug Administration-ah hian inziak lutin, Medical Oxygen siam phalna kan

nei bawk a ni.

**I.M :** Eng te nge raw-material-ah in hman ka hre lova min hrilh teh khai? Raw Material-ah harsatna te a awm ve ngai em?

**LZ Ox:** Oxygen siam nan hian raw material hrarpa em em a awm lo a, boruak (air) hi a ni mai a. Boruak kan tihah hian *nitrogen*, *oxygen*, *carbon dioxide*, etc, te a awm a. Boruak zaa sawmhnh (20%) hi oxygen a ni a. Boruak hi khawl hian a hip lutin a thli fim a, chumi hmang chuan **oxygen gas** hi siamchhuah a niin a bur (cylinder)-ah hian kan thun thin a ni. Raw material-ah chuan harsatna kan nei lo a ni.

Amaherawhchu oxygen siamchhuahna khawl ti nungtu atan hian electric / power supply tha kan mamawh a. Power lamah hian a chang chuan kan duh khawp *voltage* kan neih loh thin avang zawk hian oxygen kan siamchhuahnaah hian harsatna

kan nei ve leh ḫin.

**LM:** Ni khatah (a tlangpuiin) boruak (air) eng zat nge in hman, a chhut theih em?

**LZ Ox:** Boruak (air) kan hman zat hi chu chhut a harin, a theih lo ang a ni.

**LM:** In product Oxygen hi school zirlaia kan zir ang oxygen kha a ni em? A pure leh pure lo a awm thei em?

**LZ Ox:** Oxygen kan siam chhuah hi school zirlai kan zir ang tho kha a ni e.

A pure leh pure lo hi awm ve thei e. Amaherawhchu, chutiang ang chu a khawl lam fel loh vang a nih loh chuan a thleng zen zen lo a. Kan oxygen siamchhuah reng reng hi a thianghlim tawk em tih hi kan endik ve reng a. Ni tinin oxygen hi a bura (cylinder-a) kan than hma hian kan test ziah ḫin a. Medical grade kan tih damdawi in lam atan hman tlaka thianghlim a ni e.

**LM:** Thawktu hi eng zat nge in rawih le? In duh ang thawktu in nei thei em?

**LZ Ox:** Tunah hi chuan thawktu hi pasarh kan awm a.

A tir lam kha chuan thawktuah hian a buaithlak khawp mai a Oxygen khawl enkawl tur hian thiam thil bik nei nih a ngai a, mizo te zingah trained worker (skilled worker) kan neih loh avangin state pawn lam mi kan chhawr a. Skilled worker/Trained worker kan neih tawk lo ḫin hi a buaithlak khawp mai. Thiamthil bik ngaih lohna hnaah hi chuan kan mizo tlangval te vek kan hmang. Duhthusam chu ni lo mahse tunah rih chuan thawktuah hi chuan kan lungawi thawkhat e.

**LM:** In siam (processed) sa te chu hralthna

lamah harsatna in nei em?

**LZ Ox :** Oxygen kan siam sa hi chu a hralthna lamah hi chuan harsatna kan nei lem lo.

**LM:** Khawilaiah te nge in pek (supply) a, an mamawh ang zat in pe thei em?

**LZ Ox :** Kan Oxygen siam hi Mizoram Sawrkara damdawi in hrang hrangah te, Private Hospital ah te, Oxygen hawh chhuah na (oxygen rental) siam te hnenah hian kan pe a. Tin, heng welding tihna workshop / hnathawhnaah te hian kan pe bawk. Tunah rih hi chuan an mamawh ang hi chu kan pe thei zel e.

**LM:** Pek ḫin zat bituk in nei nge, mamawh an rawn sawi chawp?

**LZ Ox:** Heng oxygen hmang ḫin kan sawi tak te hian an mamawh zat an rawn sawi a, a bur ruak an neih ang te an rawn keng a, chung chu kan lo thun sak mai ḫin a ni. A then hi chu an mamawh zat an rawn sawi a, keimahni bur (cylinder) neihsa aṭangin an kan pe mai ḫin a ni.

**LM:** Hetiang industry pawimawh din hi tifuh in inti em?

**LZ Ox :** Hetianga industry kan han awm ve tak avang te hian tunah chuan kan Oxygen mamawh ang hi chu Mizoram chhung aṭang ngeiin kan intodelh ve tawh a ni a. Hmania Silchar vel aṭanga Oxygen, damlote mamawh zuk phur ngai kha a awm ta miah lo a ni. **LZ Ox :** Ni e, Sorkar hmalaknaa Industrial Estate kan nei hi a lawmawmin a ṭha hle mai a. Industry dinna tur ram te kan neih phahin tun hun hi kan lo thleng thei a ni a. A ram

Heng te avang ringawt pawh hian tifuh kan in ti ve khawp mai. A mamawhte tan man tlawm zawk leh awlsam zawkin, Silchar atanga zuk laks ngai tawh miah lovin Mizoram chhungah ngei kan Oxygen mamawhna te kan han phuhruk thei hi kan lawm ve hle a ni.

**LM:** In supply-naten sum leh paiah harsatna neiin in lei batsaktute an awm em?

**LZ Ox:** Sumdawnna ah te hi chuan ba tawk hi chu an awm ve ziah a. Kan hnathawhna tibuai thei khawpa lei min battu hi Pathian zarah kan nei rih lo.

**LM:** A nih leh heta tan hian dan leh dun zawm ngai a awm em, zawm tha in inti em?

**LZ Ox:** Kan Oxygen siam hi damlote hman tura tih thin a nih deuh ber avang hian Food & Drug Administration, Health Department hnuaih hian medical oxygen siam phalna (drug liscence) kan nei a. A thawktute rawn kalin kan khawlte, hmanrua te rawn endik vekin kan oxygen thianghlim leh thianghlim loh pawh an rawn endik thin a ni. Dan awm ang hi chu kan zawm tha khawp mai.

**LM:** A nih chu, a lawmawm e. A nih leh district dang/khaw dangahte in zuar/hralh chhuak em?

**LZ Ox:** District dang ti mai ila, Aizawl district piah lamah hi chuan damdawi in nen hian kan indawr deuh ber a. Mimal anga rawn la pawh tlem chu an awm ve tho.

**LM:** Ti daih ila, Industry Dept. ram (estate) ah in awm a, annual fee te in pe regular em? A rate hi to in ti em? Phalna nei lo a awm te hi eng nge i ngaihdan?

kan luah man (annual fee) hi chu Industry Dept-in ram min pek dawna kan intiamkam ang ngeiin a hun takah, kum tin kan pe zel a ni.

A ram luah man (rate) hi tunah chuan a to pawh kan ti hran lo. Tunlaia ram leina man leh ram hlutna te ngaihtuah phei chuan to lo tak a ni.

A hmaa kan lo sawi tawh ang khian hetiang Oxygen siamna kan neih theih chhan hi Sorkarin Industry Dept kaltlanga Industrial Estate-ah ram min pek vang leh phalna min pek avang chauh a ni kan ti thei ang. Amaherawhchu, he Industrial Estate chhungah hian phalna nei loa awm an awm zel chuan industry din duh leh tum tak takte tan harsatna a thlen thei dawn a ni.

**LM:** A nih leh Sorkar atangin puihna eng emaw tal in dawng tawh em?

**LZ Ox:** Sorkar atang hi chuan a Industrial Estate-a ram min pek bak hi chu tanpuina / subsidy hi chu kan la dawng lem lo.

**LM:** Mizoram hi ‘No Industry State’ te an ti fo va, hetiang mipui mamawh siamtu industry-te in lo awm reng si a; mipui pawh hian oxygen hi Mizorama siam a nih leh nih loh pawh an ngaihtuah lo niin a lang si a. ‘No Industry State’ ti a han sawi chu a inhme lo deuh i ti ve lo maw, eng nge i ngaihdan?

**LZ Ox :** Nichina kan sawi ang khian, Mizoramin kan oxygen mamawh ang hi chu Mizoramah ngei kan siam vek tawh a. State tak avang hian Mizoramah ngei pawh damlote tan oxygen tlawm zawka laks tur a awm phah mai bakah hian oxygen tlakchham emaw a tlem avanga damdawi in lam buai te

dang atanga kan lak luh a ngai tawh miah lo a ni. Mipui tam zawk hi chuan hei hi kan la hre lo pawh a nih ka ring. Heng avang te hian ‘No Industry State’ han tih hi chu a dik lo deuh chuan ka hria.

**LM :**(a tlangpuiin) Thla khata raw material mana in hman zat, hnathawktu hlawh te paikh hnuah lawkna in hmuh zat min hrilh thei em?

**LZ Ox :** Sawi thiam a har khawp mai, a tlangpui chuan nuai hnih vel thawkchhuak ang kan ni a. Tunah rih hi chuan a lawkna tak kan la tel pha chiah lo a, kum hnih thum vel tal han vei ve se chuan a lawkna chu kan neih ve theih kan beisei.

**LM :** A nih loh leh IGC, Luangmualah P. Zalena leh Cryogenic Oxygen Industry an awm ve si a, market lamah harsatna a awm thei mai lo maw?

**LZ Ox :** Ni e, hei Mizoramah hian Oxygen siamtu hi pathum lai kan lo awm ve reng tawh mai a. A hralthna lamah hi chuan tunah chuan kan la buai lutuk lo a, nakin zel hi sawi chu a har khawp mai.

**LM :** Ni 11.9.2017 (Monday) Vanglaini chanchinbu chhuakah khan Assam District pakhata (Nashik Hospital) Damdawi inah oxygen an tlakchham thu a rawn chhuak a. Nangni avang hian damdawi ina oxygen tlakchham Mizoramah chuan kan hre ngai lo va, mipui pawh kan vannein ka hria a, industry ropuina thawkchhuaktu in lo ropui ka ti hle a ni.

**LZ Ox :** Kan ramin oxygen kan mamawhna te kan phuhruk thei hi keini pawh kan lawm khawp mai. Heng oxygen siamna a lo awm

hi a reh phah bawk a. Kan thil tih te avangin kan ram leh mipui, damdawi in ten an chhawr hi kan lawm tak zet a ni.

Tuna kan Oxygen khawl neih hian darkar khatah cubic meter 100 a siam thei a. A hriat dan awlsam zawngin han sawi ila-oxygen bur damdawi ina kan hman tlanglawn ber damlo bula an hun thin ang hi darkar khatah bur (cylinder) 65 kan refill thei ang a ni. Tin, heng welding leh damdawi ina an hman oxygen bur lian (jumbo/D type) kan tih ang hi darkar khatah bur 15 kan thun (refill) thei a ni. Tun dinhmunah chuan kan state chhunga Oxygen mamawh ang hi chu kan khawl hian hneh takin a chawm thei reng a ni. Pathian zarah mipui mamawhna te kan phuhruk ve thei hi kan lawm tak meuh meuh a ni.

**LM :** A tawp nan in hmalak tum zel dan emaw lawmthu emaw sawi duh i nei em?

**LZ Ox :** Kan hnathawh dan (service)-ah hian hmasawnna tur tam tak kan la nei a. Tun aia service tha leh rang, min dawrtute tana awlsam zawk ni bawk nih kan tum mek a ni.

Lawmthu sawina tur hi a tam khawp mai, mimal hming ang chuan sawi dawn ila chuan kan sawi seng kher lo ang. Chuvangin tun dinhmun kan thlen theih nan'a min duhsaktute sorkar dept. hrang hranga thawktute leh duhsak taka kawng leh tih dan min kawhhmuhtu, thahnem ngai taka kawng tin renga min finchhuahntute zawng zawng chhungah lawmthu kan sawi tak meuh a ni.

**LM :** Hun tha tak min pek avangin kan lawm e.

**LZ Ox :** Kei pawh le.

## **INDUSTRY HLAWHTLING TAKA DIN TURIN THIAMNA LEH TUMRUHNA A NGAI**

Mi hausa, ram hausa, an lo ni mai thin. Computer software siam lama mi hlawhtling Bill Gates-a kan hre lar em em a. A chanchin sawi tam ngai lovin khawvel hian a hre chiang em em a. Ram pawh thilsiam lama hlawhtling chu an ropui thin. Kan chhehvel ram China te, South Korea te, Japan te, Taiwan te leh khawthlang ram tam tak ropuina pawh thilsiamna hlawhtling tak tak an lo din tawh vang a ni ber mai. Chutiang industry hlawhtling taka din theihna tura thil tul tak mai, thiamna leh tumruhna kan sawi dawn a ni.

Industry chu midang tih theih bak tihna hmun ang pawhin sawi ila a dik thei ang a. Thiamna hmanga mihring mamawh chi hrang hrang siam chhuah a nih hian chu thilsiamna chu a hlawhtling thin. Thiamna chu chi hrang hrang a awm thei ang a. Zir avanga thiamna a awm thei ang a. Tin, pianpui thiamna a awm thei bawk ang. A eng pawh pawh hi industry hlawhtling taka din tur chuan ko ri an tu thei ve ve a. Thiamna tam ber hi chu a zira zir chhuah a ni a. Eng ang thiamna pawh hi a zira zir chhuah pawh ni se. A bul inghahna chu pianpui finna leh thiamnaah a in nghat fo thin. Engpawh ni se, industry hlawhtling taka din turin thiamna a ngai a ni tih kha han chiang phawt mai ila.

Industry thenkhat chu a siamtu

thiamnaah a innghat a. Pianpui thiamna nei mi an awm a. Chutiang mi chuan thil han siam mai hi an sam em em a. Tuma la siam ngai loh, mihring mamawh siam chhuak thei khawl hmuchhuak reng mai mi, danglam tak an awm thin. Chutiang mite chu an hlu a, an thiamna hmanga industry din a nih hunah hlawhtlinna hmuah a awlsam thin. Industrial Tour ka tel ve tuma ka thil hmuah pakhat han sawi chhuak zawk ila. Punjab State-a Ludhiana khua kan tlawh tumin cotton wool recycle-na hmun kan tlawh a. Kan awm chhung ringawt pawhin cotton wool chhe tawh tractor trip eng emaw zat a lo thleng a. A lo singsa fel tur ringawt hi mi 2000 vel lai an ruai a. A neitupa chuan a khawl lianpui mai chu a chhuang em em a. A ma

hmuhchhuah a nih thu leh midang tan siam ve mai mai chi a nih loh thu a sawi nghe nghe a. He pa hian a thiamna special tak mai hmangin he khawl hi a siam a. Mi sang tam tak tan eizawnna a siam bakah, sum tam tak a hmuh phah a. Industry hlawhtling leh an state pawhin an chhuanvawr, state pawn atanga lo kalte tlawh atan pawha an tarlan a lo ni ta hial a ni.

Hetiang bawk hian America ram din chhuahna leh hausakna thuruk an sawi apianga an hmaih ngai hauh loh George Carver-a chanchin kan hre tawhin ka ring. George Carver-a pawh hian a thiamna zawng zawng sawm khawmin thilsiamna din tur eng emaw zat a hmu chhuak a. Chung a thil hmuhchhuah chu a takin company-te'n an han kalpui meuh chuan America ram ropuina leh hlawhtlinna tlentu lian tak a lo thei ta.

Hetiang thiamna ni kher lo a zirna lam pawh hi a pawimawh em em a. Mizoram chhunga industry tam tak hi thiamna nei tura zir chhuak an tam lo hle awm e. Hetiang zirna nei lem lo, industry hlawhtling taka lo dintute hi eng vanga hlawhtling nge an nih tih ngaihtuah ta ila. Heng mite hlawhtlinna thuruk chu an thil tih tuma an tumruhna hi a ni fo mai. Mi tam tak industry din tura theih tawp piah lam thleng rawka ṭan la, a tawp a hlawhtling tak sawi tur an awm nual ang.

Electric bulb hmuchhuaktu Thomas Alva Edison-a chanchin pawh hi kan hre fo tawh ang. A luhlulzia leh tum ruhzia hi sawiin a siak lo a ni. Electric bulb ti eng tur hian

bulb vawi sangkhat chuang a ti keh a, vawi sang chuang a hlawhchham hnuah khawvel mamawh tak mai electric bulb chu hlawhtling takin a siam chhuak thei ta a. Electric bulb siamna industry tam tak a lo ding chhuak ta ṭuk ṭuk mai a ni.

Aw le, Mizoram chhungah hian mit han len ta ila. Kan thil siamtute han thlir hian lehkha zir sang leh thiamna nei ai chuan mi naran industry dintu an tam zawk niin a lang. Hei hian thiamna nei tan kawng a inhawn zauh zia a tarlang thei ang. Thiamna bik nei lo mahin hlawhtling taka indutry an din theih chuan mithiam leh zir sang zawk tan chona lian tak a tling thei awm e.

Indutry dintu rau rauah thiamna nei chuan midang biang biak kawngah te, dan leh hrai hriatchian kawngah te, hnathawktu leh office enkawl kawngah te changkang zawk leh fel fai zawka kal pui thei tura ngaih a ni a. Hralhna lamah pawh khaw hawi zau zawk tur leh mi naran aia hmang chang pawh hre tura ngaih a ni a. Chuvangin, mi naran aiin hlawhtlin awlsam zawk tura ngaih an ni. Industry hlawhtling taka lo din tawhtute hi mi haus a leh sum ngah an ni kher lo fo va. Harsa tak atanga bul ṭan, zawi zawia thanglian leh hlawhtling chho ta sawi tur an tam khawp mai. Tun laia lar em em, KFC (Kentucky Fried Chicken) kan tih pawh hi a siamtupa chu dawr tinah a thlalak an tar ṭhin hi kan hmuh ka ring. Putar upa deuh mai a nih hi. Arsa a siam tirh hian a putar bik hauh loh mai kum tam tak a hlawhtlin mai loh hnuah, a lo putar hial hnuah a lo hlawhtling ve chauh va. Khawvel pumpui hriat, mi

hlawhtling leh hausazingah chhiar tel loh theih loh a lo ni ta reng mai a. Hetiang hi a nih avangin, industry hlawhtling taka din turhian tumruh a ngai a, chhel a ngai em em a ni.

Industry hlawhtling taka din phut hi a awl-ai lo va. Zawi zawia harsatna chi hrang hrang kara din chhuah a ni tlang pui a.
