Kan hotute rem min ruatsakna avangin Indian International Trade Fare 2009 chu New Delhi-a Pragati Maidan hmunah ka zuk chhim ve a. New Delhi-a ka cham chhunga kan hotute min duhsakna leh ṭha taka min lo dawnsawnna avangin, “Lawmthu sawi ka theih nghilh hauh tur a ni lo,” ti rilru phan kha ka ni a, tun hi hun remchangah ngaiin an chungah lawmthu ka sawi nghal e.

He trade fare hi dt 14-27 Nov., 2009 chhunga neih a ni a. Ni hniih chhung tlawhna hun remchang ka neih chu ka tui vena thilsiamna khawl entirna hmunah ka hmang zo deuh vek a. Foreign pavilion leh hmundang tlem tih bak chu ka tlawh vak ta lo. Mizoram pavilion-a kan thil phochhuah leh kan hrallchhuahte pawh kei aia hrechiang leh sawi thei an awm ring chungin ka sawi turah ka dah ta lo bawk a. Chuvangin, NSIC Pavilion No.12 chhunga thilsiamna khawl leh thilsiamna lam kaihhnawih thil, thilsiamna din tur leh din mekte ṭangkaipui tura ka ngaih ka han sawi mai ang e.

A hmasa ber atan chuan thilsiamna din tur tana thil pawimawh, a tel lova hmalak tan theih loh tluka ngaih, Project Report siamtute in phochhuahna hi han tarlang hmasa ta ila. Kum dang ang lo takin tun tum IITF-ah hian Project Report siam chi an in phochhuak tlem hle mai a. Agency pahnih

chauh an in phochhuak a. Amaherawhchu, pahnih chauh mah nise, anni pahnih hian India rama viable project awm thei ang chi zawng zawng chu an bel hle tho va. An tlem lam ngaihtuah lova, an tih theih zawng ngaihtuah chuan innghahna tlak leh hmun dang tel lo pawha tleina tawk chu an ni hrim hrim tho mai.

Project Report pakhat man hi (hard copy emaw soft copy a leitu duh zawk zawk) Rs. 500.00 an chhiar a. A pahnih duh tan chuan Rs. 1000.00 a ni. Project Report pakhat nei turin sen a ngai tihna a nih chu. An Project Report hi thlir chian ve ka duh avangin ka phak ang chin tawk tlemte chu ka lei ve nghe nghe a. Sum hum deuh ni ila chu

Project hrang hrang a tul huna phawrhchhuah leh atana han leikhawl a chakawm hle mai. Mahse, ka sum neihin daih ngang hek lo le, ui tak chungin ka thlir liam ta hlawm a.

Khai le, a khawl phochhuah lam thlir leh ta thung ila. Sawi tawh ang khan khawl phochhuaktute hi kum dang ai chuan an tlem deuh va. Thilsiamtu 40 velin an thilsiam ang zel an phochhuak a. An zuar nghal vek bawk a. Heng zingah hian Mizoram kan la chin em em loh thil tam tak a awm a. Chung zinga thenkhat han tarlang ta ila a tha awm e.

Pakhatna atan chuan chhang urna khawl phochhuaktu hi company pathum lai an awm a. Chhang urna khawl ‘Electric oven’ Rs. 4 .00 lakhs atanga Rs. 10.00 lakhs man an phochhuak a. Electric oven hi a thatna riau a awm a; hmun a duh zim a, meikhu a chhuah lova, chuvangin midang tan a hnawk lo. Thing hmanga oven neitute tan thing tuah tur dahna hmun zau tak a ngai a. Thing ehna hmun pawh an mamawh thin. Electric oven erawh hi chuan chung chu a mamawh lova. Oven hi a bungraw dang nen a lian ber thleng hian ft 12 bial chhungah a khung zawh vek theih a ni. Chuvangin, hmun a heh lo ringawt pawh hi sawi mawi leh chin lar tlak a nihna tilangtu a ni ngei ang.

Khawl pakhat a lian deuhte phei hi chuan chhang an ur hnem thei hle a. Darkar khatah chhangthawp tlawn 300 lai an siam thei a. Nikhatah darkar riat hna thawk ta se,

chhangthawp 24000 lai harsa lo takin an siam thei tihna a ni. Over time-a an thawh phei chuan nikhatah tam tak an siam thei a nih chu.!

Packing khawl lam hi han thlir leh ta ila. Packing machine chi hrang hrang entir a ni a. Thenkhat chu ‘Kurkure’ siamna leh packing ti nghal thei te, packing machine ringawt te, lunch packing machine (Hei hi thlawhna leh Rajdhani rail-a eitur pack an sem ang pack-na) te leh chi hrang hrang phochhuah a ni a. Kan ramah hian ei tur packing lam hi ka uar lo hle a. State pawn leh ramdang atangan pack sa kan la lut mai a. Ei tur packing hi uar thar ve ta ila. Peg lunch, vegitable hamburger te, sandwich leh ei tur chi hrang hrang pawh hi siam ve ta ila. Office kal mite leh sikul naupang pai mai theih, water proof packing heng khawl hmang hian kan siam thei a. Chin ve atan ka it khawp mai. Eizawnna thar lam leh hlawhtling tak ni thei turah kei chuan ka ngai a ni.

Heng bakah hian Alu chips siamna, Alu velna atanga slice-na, tih rona leh packing thlenga zawh fel thlap theihna te pawh entir a ni a. Thilsiam lama tuimite tan chuan zira, tih ve nghal mai a chakawm duh khawp ang. A bik takin Mizo pa chuan heng an siam lai

hi vawikhat kan thlir chuan kan ti ve thei nghal mai a. Khawl hi leiin han bun ve ila chuan Alu chip siamna ang hi chu zirna dang ngai hauh lova kan din puitlin ve theih

nghal a ni a, thilsiamna din remchang takah ka ngai nghal bawk a ni.

Thil nawhmamna, rangkachak, dar leh silver ang chi nawhmamna khawl pawh hi kan ramah kan la hmang lova. Kut hnu a mam duhin, hnuhma a mawi a. Kan khawpuia rangkachak chher leh tlereuh siama eizawngtute hman atana it awm tak tak an phochhuak bawk a ni.

Steel fabrication - thir hmanga kan eizawnna atana ṭangkai tak mai khawl chi hrang hrang phochhuah a ni bawk a. Thir phek emaw duh ang anga denna, angle degree hrang hrang kan mamawh ang anga awlsam taka denna te, thir chhah leh zau zawka verhna hmanraw hrawl tak tak te, duh ang chen chen a sei a tan chhumna khawl te, phochhuah a ni bawk a. Hengte pawh hi kan ramah kan la hmang rih lova. Ṭangkai taka hman ve a chakawm hle mai.

Heng bakah hian home scale offset printer aṭanga offset printer lian tak tak te, grinder te tak te aṭanga lathe machine lian pui pui te, buhdengkhawl leh chhangphut herna te, oil herna khawl te, biscuit mihring kut tel lova siam chhuak zung zung thei te, paper cup leh paper plate siamna te, bekang bawngchnute siamna khawl te, plastic bottle siamna/hampuarna khawl te, lungtat vir chi hrang

hrang te leh lian pui pui te he trade fareah hian phochhuah a ni.
